The Kauai Food Bank (DBA Kauai Independent Food Bank) warehouses mass quantities of food and distributes in manageable portions for agencies that feed the needy. Food is gathered from the community, local grocers, and from sources off-island and distributed to fifty-one not for profit agencies or churches who give food directly to qualified individuals without charge. In 2011, we responded to 116,437 request for emergency food; and a total of 677,009 pounds of food was distributed, valued at \$1,083,214. The Kauai Independent Food Bank also provides job training and skill building to needy individuals. An independent study by Feeding America has determined that Kauai Independent Food Bank (the smallest See Form 990, Page 2, Part III, Line 4a (continued)

4b (Code:) (Expenses \$ 39,496. including grants of \$ 27,500.) (Revenue \$ 28,086.) The Keiki Cafe provides 7,250 pounds of super-sized nutritious food products to children aged 7 - 17 at The Boys and Girls Club, Waimea Clubhouse. This was the sixth year of this program. Needy youth are provided after school foods in a safe, structured environment and offered nutrition education, and other services. In 2011, the Backpack program provided 15,518 pounds of nutritious food products to needy youth at the Kapaa Boys and Girls Club. A total of 4,486 youth servings were made in 2011, all of which were packaged in unmarked backpacks and distributed each Friday for use over the weekend.

4c (Code:) (Expenses \$ 156,138. including grants of \$ 5,000.) (Revenue \$ 137,555.) SNAP Outreach program secured a total of \$339,005 in new food stamp monies for Kauai. USDA has determined that the economic benefit for these new SNAP dollars would be about \$623,000 in economic benefit for the Kauai community.
