FOOD IS GATHERED FROM COMMUNITY BUSINESSES AND ORGANIZATIONS, AND INDIVIDUAL CITIZENS. THE FOOD IS DISTRIBUTED TO 37 NOT-FOR-PROFIT AGENCIES/CHURCHES WHO, IN TURN, GIVE FOOD DIRECTLY TO QUALIFIED INDIVIDUALS WITHOUT CHARGE. IN 2018, WE RESPONDED TO 20,164 REQUESTS FOR EMERGENCY FOOD; AND A TOTAL OF 97,747 POUNDS OF FOOD WAS DISTRIBUTED, VALUED AT \$155,417.73.
